

GRRband For-Profit Music License Terms (*This is not proof of a license*)

1. License Overview

This license agreement governs the for-profit use of music by GRRband and Riffuge Studio Productions LTD. It is intended for usage in broadcast media, television, streaming media, or other commercial formats. This document outlines the fee structure, usage terms, and limitations of for-profit licenses. Note: This document itself is not a license.

2. Fee Structure

- **One-Time Fee Per Song:** A minimum of \$1,000 per song for limited use.
- **Tiered Fee Schedule:** Fees may vary depending on:
 - **Intended Use:** Commercial advertisements, television, film, or streaming.
 - **Project Reach:** Local, national, or international distribution.
 - **License Duration:** Standard license is for one year, with options for renewal or extension.
- **Bulk License for Full Catalog:**
 - The entire catalog of 777+ songs is available for bulk licensing at \$500 per song (half-rate). (Expires after 10 years)

3. Percentage Fee Basis

A percentage-based fee option may be negotiated based on the following:

- **Flat percentage of project revenue** based on the significance of the music's use.
- **Sliding scale** depending on reach and duration.

4. Cover Version Terms

- **Cover Version Licensing:**
 - Must include full attribution of original usage.
 - Lyrics, ownership, and copyright must be attributed to GRRband.com or Riffuge Studio Productions LTD.
 - Reworking of lyrics is allowed only with prior written approval from the band.
 - Live public performance license coverage per event of \$200 per song.

5. License Limitations

- **Non-Transferable:** All licenses are non-transferable and may not be assigned to third parties.

- **Project Scope:** The license is granted on a per-project basis and may not be used for future projects beyond the original scope without a new license or extension.
- **License Duration:** Standard licenses expire after one year unless otherwise stated in the agreement.

6. Refunds and Termination

- **Non-Refundable:** All fees are non-refundable.
- **Violation of Terms:** Any violation of the terms will result in immediate termination of the license.

7. Copyright and Attribution

- **Attribution:** All licensed music must retain attribution to GRRband or Riffuge Studio Productions LTD.
- **Usage Restrictions:**
 - Music may not be used in a derogatory, defamatory, or hateful manner.
 - Music may not be used to promote hate speech or organizations classified as such.

8. Serialized Licenses

- Each paid license is serialized and recorded by our legal team.
- License usage violations will be met with legal action, including:
 - Recovery of the intended license fee.
 - Additional damages and legal fees.

9. Legal Remedies

Violations of license terms may result in:

- Lawsuits for damages.
- Percentage-based penalties determined at the time of legal proceedings.

10. Disclaimer

This document is not a legally binding license. All paid licenses are executed through a separate serialized contract.
